3. The Photographer(s) will document the events in a photojournalistic style and make formal portraits as requested by the client. The client must complete the attached wedding questionnaire and return it no later than two weeks before the wedding day. The photographer(s) will attempt to accommodate all requests but will not be bound by extenuating circumstance such as late arrivals of bridal party members or friends and family or refusal of third parties to cooperate fully.

4. All requests for photography must appear on the **Photography Questionnaire**.
5. The Client will ensure that the guests at the event do not interfere with the photographer's work. During the pre/post-ceremony portrait session, the photographer must be the only one taking pictures.
6. The photographer(s) is under no obligation to display the images while the event is still underway.
7. The Photographer retains the copyright to all images.
8. If the Photographer is unable to perform due to fire or other casualty out of his or her control, or due to the Photographer's illness or injury then the Photographer shall return the 50% deposit to the Client but shall have no further liability with respect to this agreement. This limitation on liability shall also apply in the event that images are lost through equipment malfunction, lost in the mail or otherwise lost or damaged without fault on the part of the Photographer. In the event that the Photographer fails to perform for any reason, the Photographer shall not be liable for any amount in excess of the Photographer's fee.
9. PACKAGE SELECTION: (please choose one)

\_\_\_\_\_ The DMD Silver Wedding Photography Package is designed for the young couple starting out on life with a tight budget, but who still insists on great wedding photography. Rates start at \$1200. The Silver Wedding Photography Package includes the following: -Up to 4 hours of photography including formal portraiture of the entire wedding party. This package is intended for bridal parties of 10 or smaller including the bride and groom. -Image CD with permission to print -Online proof gallery -Option to order gorgeous heirloom prints from my online store -Option to add a la carte items from the website Silver packages may not be available at all times during the year. Peak times such as summer and Christmas may be held for premium reservations. Silver packages are not available for weddings that require travel planning. Please call to check availability.

\_\_\_\_\_ The DMD Gold Wedding Photography Package is a more thorough package which includes six hours of photography time. This is perfect for brides with wedding parties consisting of more than 10 people. Rates start at \$1500. The Gold Wedding Photography Package includes the following: -Image CD with permission to print -Up to 6 hours of photography including formal portraiture of all members of the wedding party and any family members of the bride and groom you wish to include. -Online proof gallery -Option to order gorgeous heirloom prints from my online store -Option to add a la carte items from the website

\_\_\_\_\_ The DMD Platinum Wedding Photography Package is our best package. It includes a full day (8 hours) of wedding photography, rehearsal and rehearsal dinner coverage, plus a second two-hour photo shoot. This second shoot can be used months in advance for engagement photos, just before the wedding for off-location shots of the bridal party (beaches, museums, landmarks) or after the wedding for specialty photo shoots (new home, trash the dress, etc.). Rates start at \$1800. The Platinum Wedding Photography Package includes the following: -A full day of photography coverage including formal portraiture of all members of the wedding party. -Image CD with permission to print -Rehearsal and Rehearsal Dinner Coverage by one camera -A second two hour photo shoot which can be used at the bride's discretion anytime from 12 months before the wedding to 2 months after. -Online proof

gallery -Option to order gorgeous heirloom prints from my online store -Option to add a la carte items from the web site

Payment is to be made as follows: 50% non-refundable deposit due at time of signing. Full balance including travel expenses is due with the completed wedding questionnaire sheet no later than fourteen days before the ceremony. At that time, the wedding is considered finalized and NO REFUND will be issued in the event that the wedding is canceled or postponed. In the event of a postponement, the photographer will do his best to accommodate the client, but will not be bound by the terms of this contract. No refund (in part or whole) will be given in the event of postponement.

Galleries will be available approximately 6-8 weeks after the wedding date and will be available to view online in your own private album .
